Phone brainwave

Staff at the Dhule network have come up with a great idea; their own confidential telephone helpline, Aamhi Aanandane Jagto (*We are living happily*). It provides immediate and accurate information to anyone with an interest in HIV and AIDS. Dhule staff believe good information is vital for a more informed society. Callers can include positive people, those who are affected, or anyone with a query about HIV or its transmission.

Positive people suffering from stress or depression can ring to talk to a positive person. The message they will receive is that you can live happily with HIV and lead a free and satisfying life.

In a novel way of keeping track of customer satisfaction, there is an SMS facility for people who have used the helpline to say whether it was useful. A large majority, 79%, have said it was.

- At a recent board meeting the Network of Maharashtra People with HIV (NMP+) adopted new Human Resources and Finance Policies, as well as a Communications Strategy, and Communications Style Guide. Information about how these **improvements in our governance** will affect all of us will be communicated gradually over the next few months
- Pravin Salunke has sent out details of **bank lending schemes** that might help positive people. Districts should approach the banks in your area and start discussions about the needs of positive people as individuals, and in groups such as income generation groups. Most banks have Small Scale Industries Schemes, Agricultural Schemes, and give house loans. Please contact Pravin if you need any advice
- districts need to send in a **Legal Case Study** each month. These are analys to show the greatest problems, issues and needs facing positive people
- The working relationship between NMP+ and the **Human Rights Law Network** continues with the first legal advice column (see next page). They are also pursuing the right for 2nd line treatment in the Bombay High Court.

The Jalna network has its own unique way to show there is no need to fear positive people. They have set up a drinking water table outside their office so that people can ease their thirst with a drink of good water.

The Good Samaritan act will remain in place through the hot summer.

Female sex workers; own forum

Positive female sex workers in Maharashtra now have their own forum. At a recent meeting at NMP+ offices, the forum was established and a board chosen. They will meet quarterly. There are 7 board members, from Raigad, Sangli and Pune. Included on the board as an Executive Member is NMP+ board member Prema Khandagle. More news

- Pune, Bhandara and Sangli districts all achieved more than 100 **outreach visits** this month.
- All districts were represented at a Six C meeting at Pune INP+ offices this month. Each district is asked by the INP+ Action Group to contact their member of parliament and ask them questions on how they have treated the need for greater TB control. They will be asked about six areas including use of Communication, Capacity building, and how well informed they are themselves about TB.

Avahan 'captured'



The Avahan project which helped NMP+ develop its advocacy and capacity is coming to a conclusion. The project also helped Kolhapur District to develop as a model network. There will be a meeting in Chennai at the end of April to discuss ways of consolidating the improvements.

The project has been captured in photographs by eminent photographer **Shaju John**. He was commissioned by INP+ and Family Health International to produce a photography book. The book will have 100 images of positive people from different states. This includes Mumbai, Panvel, Ratnagiri, Solapur, Kolhapur, Aurangabad, Beed, Osmanabad and Ahmednagar districts of Maharashtra. It will show positive people from a variety of backgrounds living happily, to motivate others to live with dignity. Photos from the project will go on display in Chennai on 28th of April and will tour to other cities including Mumbai and Pune. The book will be published later this year.

Women - claiming your ancestral property

Today NMP+ is delighted to bring the first of a series of legal advice columns from the **Human Rights Law Network (HRLN)**. They are happy to take further queries on legal matters using the contact details below.

Women are entitled to inherit ancestral property from their parents in the same way as their brothers (Hindu Succession (Amendment) Act 2005), regardless of their marital status. Women can face difficulties enforcing this right because of society's attitudes towards women inheriting property, and these are magnified when the woman is HIV positive.

Women also face problems because it is harder for them to get the documents they need to prove their claim to the property. No specific documents are required by the legislation, but the following will help strengthen a woman's case:

- 7/12 extracts (property details, for agricultural land in rural areas, available from the Land Records Department)
- Property Card (property details, for urban areas, available from the City Survey Office)
- Electricity/Water/Telephone bill
- Any document containing a description of the property
- Proof of residence ID
- Proof of marriage (e.g. invitation card, photographs of the marriage)
- Affidavits of the facts about the property and the woman's share

Women wanting to pursue a property claim should bring as many of the above documents to the lawyer as they can, so the lawyer can present the best case possible.
